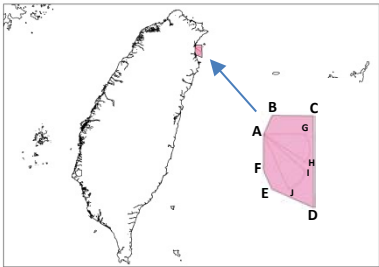
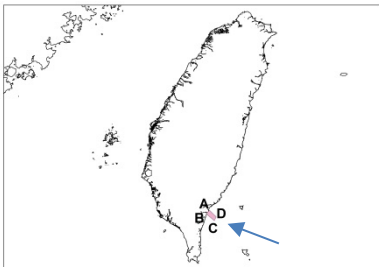

項次(A)

1. 請漁業廣播電台於本場射擊時間內每日定時廣播，以維護海上作業船隻安全。
2. 請基隆海岸電台依據全球海上遇險及安全系統國際公約(GMDSS)相關規定於本場射擊時間內每日定時廣播並發送航行安全警告電傳信文。
3. 各單位如有飛行器欲通過靶區上空，請飛航管制台先行電話告知通過時間，本場配合暫停射擊。
4. 漁民撈獲及民眾發現疑似未爆彈(或爆裂物)，籲請立即通報警察(電話110)或海巡機關(電話118)處理，切勿擅自移動、搬運，以免肇生危安情事。
5. 請海巡署北部分署於射擊時間協助管制實施戒護。
1. Fishery radio stations are requested to broadcast at scheduled times daily during the firing period to ensure the safety of vessels operating at sea.
2. Keelung Coast Radio Station is requested to broadcast at scheduled times daily during the firing period and send navigational safety warning messages in accordance with the relevant provisions of the Global Maritime Distress and Safety System (GMDSS) Convention.
3. If any aircraft intend to pass over the target area, please call Air Traffic Control in advance to inform the air traffic control station of the time of passage. We will cooperate and suspend firing.
4. Fishermen and the public who discover suspected unexploded ordnance (or explosives) is urged to immediately report to the police (call 110) or the Coast Guard (call 118). Do not move or transport without authorization to avoid any danger.
5. Northern Branch, CGA is requested to assist in control and security during firing hours.

1. 操演空域已與各航空公司及航空站協調完畢。
2. 航空器及船舶請避開管制區域以策安全。
1. Airspace control has been coordinated with all airlines and airport authorities.
